Township of New Britian Open Space Plan Survey Executive Summary

Overview

ETC Institute administered an open space plan survey for the Township of New Britian, Pennsylvania during the early months of 2024. The purpose of the survey was to help determine parks and recreation priorities for the community.

Methodology

ETC Institute mailed a survey packet to a random sample of households throughout the Township of New Britian. Each survey packet contained a cover letter, a copy of the survey, and a postage-paid return envelope. Residents who received the survey were given the option of returning the survey by mail or completing it online.

After the surveys were mailed, ETC Institute followed up with residents to encourage participation. To prevent people who were not residents of New Britian from participating, everyone who completed the survey online was required to enter their home address prior to submitting their survey. ETC Institute then matched the addresses entered online with the addresses originally selected for the random sample. If the address from a survey completed online did not match one of the addresses selected for the sample, the online survey was not included in the final database for this report.

The survey aimed to collect a minimum of 300 completed responses from residents, and this target was surpassed with 418 completed surveys collected. The overall results for the sample of 418 residents have a precision of at least +/-4.70% at the 95% level of confidence.

The major findings of the survey are summarized in the following pages.

Parks Usage

Parks Use: Respondent selected the parks they have used/visited. The commonly used/visited parks were: North Branch Park (71%), West Branch Park (57%), and Veterans Park (42%). Then, they rated their satisfaction with the parks. The parks that respondents were highly satisfied with were: North Branch Park (88%), West Branch Park (82%), and Pheasant Run Playground (81%).

Benefits, Importance, and Improvements to Parks and Recreation

Agreement: Respondents rated their level of agreement with the statements listed in the survey. The highest agreed statement was: New Britian should acquire & preserve open space (94%).

Additional Findings

Voter-Approved Earned Income Tax for Open Space: Thirty-six percent (36%) of respondents indicated that they were aware of the voter-approved earned income tax for the purchase of land for open space.

Opinion on Open Space in New Britian Township: Respondents selected the statement that best matched their opinion on open space in New Britian Township. The statement that was highly selected was: some preserved open space should be kept in a natural setting & not for public use (88%).

Reasons for Reserving Open Space: Respondents selected all the reasons that New Britian Township should preserve open space. The common reasons were: protect or enhance woodlands, streams, wetlands, fields, meadows, & other natural resources (94%), protect habitat for wildlife (88%), and preserve scenic views & historic resources (87%). Based on the sum of top four choices, the common reasons were: protect or enhance woodlands, streams, wetlands, fields, meadows, & other natural resources (58%), stop development & prevent suburban sprawl (52%), and protect habitat for wildlife (43%).

Important Types of Open Space: Respondents selected the types of open space that are important to them. The most selected types of open space are: natural areas that protect environmental resources & wildlife but are not available for public use (86%), areas to hike on trails in natural areas & can observe nature (82%), and open areas for picnicking, relaxing on benches, playing, walking the dog, & have paved walking trails (75%). Based on the sum of top three choices, the most selected types of open space are: natural areas that protect environmental resources (60%), areas to hike on trails in natural areas & can observe nature (46%), and open areas for picnicking, relaxing on benches, playing the dog, & have paved walking trails (35%).


Awareness of Preserved Open Space Areas: Respondents were asked if they were aware of any of the preserved open space areas that are listed in the survey. The preserved open space areas that respondents were most aware of were: Cotton Park (49%), Forest Park (29%), and Coleman Property (28%). Then, they respondent how important those areas were to the community. The areas that respondents thought were most important to the community were: Coleman Property (Upper State Road-Neshaminy Creek Greenway Extension) (91%), Cotton Park (Walnut Street & Schoolhouse Road) (89%), Fairwoods (East Fairwood Drive) (88%).


Q1. Counting yourself, how many people in your household are...

by percentage of persons in household




Q2. Are you aware New Britain Township has a voter-approved earned income tax for the purchase of land for open space?

by percentage of respondents (excluding "not provided")










Q5. Please check all the reasons why you believe New Britain Township should preserve open space.



by percentage of respondents (multiple selections could be made; excluding "none")


Q6. Which four of the items are most important to you/your household?




by percentage of respondents who selected the items as one of their top four choices

by percentage of respondents (multiple selections could be made; excluding "none")




Q8. Which three of the items are most important to you/your household?




by percentage of respondents who selected the items as one of their top three choices


by percentage of respondents who responded "YES" (multiple selections could be made)

Q9. If "yes," please indicate how you would rate your satisfaction with the park.




by percentage of respondents who responded "YES" to Q9 (excluding "not provided")

by percentage of respondents who responded "YES" (multiple selections could be made)


Q10. If "yes," please indicate how important you believe the open space area is to the community.



by percentage of respondents who responded "YES" to Q10 (excluding "not provided")





by percentage of respondents (excluding "not provided")






Q13. Which of the following best describes your race?
